

MY DAD'S BRAKES MAINTENANCE & MORE!

Limited Warranty Terms:

MY DAD'S warrants those items set out below according to the applicable limited warranty terms as follows:

Limited Lifetime Guarantee on Brake Pads and Brake Shoes:

If you purchased limited lifetime warranted brake pads and/or brake shoes, as shown by proof of invoice, said brake pads and/or brake shoes are warranted by MY DAD'S for as long as you own the vehicle on which the brake pads or brake shoes were originally installed. If the warranted brake pads or brake shoes become damaged, defective or worn out* during the limited warranty period, the MY DAD'S shop will provide replacement warranted brake pads and/or brake shoes, as applicable. This limited warranty does not cover a labor charge at the then prevailing rates for installation of the replacement brake pads and/or brake shoes if replacement occurs more than 90 days after the date of original installation. The brake pads and/or brake shoes will be considered worn out when the linings minimum wearable thickness is less than the vehicle manufacturer's specifications. For bonded linings this is the minimum thickness of the lining at its thinnest point. For riveted linings, this is the measurement from the head of the rivet where the lining is most worn to the surface of the lining.

Limited 90 Day Defect Warranty:

All other parts and services not listed above are warranted from defect for 90 days from the date of installation or performance. If, during this 90 day limited warranty period any warranted part(s) fails to perform properly due to product defect or defective workmanship, the MY DAD'S shop will provide a replacement warranted part(s) as applicable. If during this 90 day limited warranty period, any warranted service is found to have been improperly performed, the MY DAD'S shop will properly re-perform the warranted service(s) as applicable.

Additional Provisions:

There are no other warranties, on these or any other products issued by MY DAD'S. To the fullest extent allowed by law, the limited warranties and remedies set forth on this document are exclusive and in lieu of other warranties or conditions, expressed or implied, including warranties of merchantability and fitness for a particular purpose, all of which are expressly disclaimed. These limited warranties give you specific legal rights. You may also have other rights which vary from jurisdiction to jurisdiction. The above referenced limited warranties do not apply to parts that are not purchased from and/or installed by the MY DAD'S shop.

With respect to the replacement of any part(s) covered by the above referenced limited warranties the MY DAD'S shop must restore the entire system to which a warranted part(s) relates to its proper operating condition. These limited warranties do not include additional parts and labor that may be required to do so.

If you do not authorize all of the work required to restore the entire system to its proper operating condition, without limitation, the installation of other needed parts, you will receive non-installed and non-warranted parts(s) as applicable and this document and the limited warranties referenced herein, shall become null and void.
